Message from ISET Director, Tamara Sulukhia



The 2021-22 academic year was challenging for ISET, as with thousands of academic institutions globally as global pandemic continued to affect lives, business and development. Nevertheless, we did not slow our ambitions or aspirations as an international school, and this year marked a major accomplishment in terms of internationalization and broadening partnerships. In May 2022, ISET's academic program, the Master's in Finance obtained accreditation from National Center for Educational Quality Enhancement, meaning that ISET will soon start its third academic program. In June 2022, ISET received confirmation of 5-year International Accreditation from FIBAA for two programs.

During past academic year 2021-22, two notable partnerships with Bremen University in Germany and Clermont-Auvergne University in France opened door for dozens of our graduate and undergraduate students and offered the chance to pursue study opportunities abroad for one year or one semester, including obtaining a degree at the University of Bremen. This partnership brought unique opportunity to students to receive two diplomas - one from ISET and another from the University of Bremen.


We sincerely appreciate our students' efforts in managing their studies alongside the many limitations and restrictions brought on by the global COVID-19 pandemic. ISET has continually pushed to apply flexibility and adaptability to accommodate various conditions in supporting the best learning outcomes for our students. Fortunately, in Spring 2022, ISET students and faculty returned to the auditoriums after almost 2 years of distance learning. However, study mode was flexible for students, meaning that they could choose attending lectures either at the ISET building or online via zoom. It helped them to adapt to the new normal conditions with less discomfort and rush.

ACCOMPLISHMENTS DURING THE YEAR

ISET Major Highlights of the 2021-22 Academic Year

- Demand for the ISET Bachelor program in 2021-22 academic year once again showed increasing trend. The demand for the program has increased in 2021 too, that kept the increasing trend starting since launch of ISET Bachelor Program. 850 students chose ISET as their preferable program, which is 100 more than last year.
- In 2021, the program ranked #1 among all economic and business bachelor programs in the country based on the Unified National Examinations scores of its entrants for the second consecutive year. Becoming top of the rankings is a significant milestone as the program is still incredibly young at only five years old. ISET Bachelor program in Economics is only such public program in the country offered in English, that accepts international students, engages a largely international faculty and has international accreditation.

✓ Partnership with the University of Geisenheim underway: 1 Bachelor program student has been selected to go to the University of Geisenheim in Germany for one year in 2022-23 academic year with Erasmus scholarship. The exchange program is a part of the Cooperation Agreement, signed between the ISET and University of Geisenheim.

- ✓ Partnership with University Clermont Auvergne (UCA) in France kicked- off! The 6 Bachelor program students have been selected to go to the University Clermont Auvergne (UCA) in France for one semester in 2022-23 academic year with Erasmus scholarship. The exchange program is a part of the Cooperation Agreement, signed between the ISET and UCA and implies exchanges of the students, faculty, staff, etc.
- ✓ Partnership with the University of Bremen kicked-off! 6 Bachelor program students have been selected to go to the University of Bremen (UB) in Germany in 2022-23 academic year to spend their final year at the UB and earn a degree from the UB along with the ISET. The opportunity is given to ISET students under the cooperation agreement between ISET and the UB.
- ✓ The first ISET election of the student representatives in Academic Board was conducted. In order to strengthen internal student representation in ISET decision-making, the Governing Board (on August 4-5, 2021) amended the by- laws and included two student representatives in the ISET Academic Board. This opened opportunity to better reflect views of ISET students generally at the academic board meetings, contribute to the quality monitoring and overall process. One student is set to represent the Master program and another one the Bachelor program, serving in the Board for one year, from Fall 2021 through the Summer. Two female students one the Bachelor program class 2023 and other the Master program class 2022 became members of ISET board for the first time.
- ✓ In 2021-22 academic year, 44 Teaching Fellows have participated in the CERGE-EI Teaching Fellowship program in the Caucasus region. ISET is an exclusive partner of the Center for Economic Research and Graduate Education Economic Institute, Prague (CERGE-EI) on the implementation of its Teaching Fellowship program in the South Caucasus. The program provides ISET graduates with pedagogical training and places them as teachers of undergraduate economics at dozens of universities in Georgia, Armenia, and Azerbaijan.
- ✓ In 2021-22 academic year 4 members of ISET administration participated in Staff Mobility Program. 2 members of ISET administration have successfully participated in the "Blended Workshop and Training for University International Officers & Deficers & Deficers and Companied by Middle East Technical University (TR) in collaboration with the National Academy of Education Administration (through the Erasmus + Program). 2 members of ISET administration have successfully participated in the Staff Mobility program and visited one of ISET's partner universities in France, namely, University of Clermont Auvergne (UCA).

Online learning modality

The ISET Bachelor program successfully continued teaching during the pandemic and enriched its capability of implementing ZOOM classrooms to deliver interactive classes. We also fully integrated Moodle tools and TSU's learning management system LMS to harmonize teaching and give students a way to get the most out of this limited environment. By the end of the academic year, ISET offered hybrid format study to students, meaning that lectures were delivered at the classroom in face-to-face mode and at the same time they were streamed online. It allowed the students to adapt step by step to the changed environment and choose the most convenient format for them.

The ISET Bachelor program curriculum continues to expand through the adding and engaging courses. We added multidisciplinary courses (e.g. Financial Markets, Political Philosophy, Communications) and related programming skills for social sciences courses. We have also extended the scope of our curriculum through partnerships, which have taken the form of remote classes. So far, that has mostly been through our partnership with CERGE-EI, who's remote learning classes are also simultaneously taken by other universities from other countries. This partnership has allowed us to add courses in energy economics, innovation economics, and core courses such as international trade.

Demand for ISET BA

University admissions in Georgia are centralized, standardized, and organized by the National Assessment and Examination Center (NAEC). ISET allocates 150 BA seats each year and this year brought a record high number of applicants, about 850, making ISET the number one business and economics program in the country. In addition to the 150 freshman seats allocated through NAEC, ISET also usually admits an additional 10% through internal or external transfers from other programs as well as international students. Despite the pandemic's effect upon international demand, we still admitted 4 international students.

Faculty recruitment

Faculty recruitment is a top priority at the ISET bachelor program. It is our goal to enrich the academic environment, support internationalization, and diversify the study plan. ISET always strives to make the program relevant with industry lead partners. Therefore, we regularly invite professional economists from policy institutes, research organizations, the National Bank of Georgia, analytic departments of commercial banks, ministries etc. ISET continues to manage the CERGE-EI teaching fellows program in the Caucasus, which provides financial support to qualified, professional economics teachers in the region.

Graduation and job placement

Nearly all of our first ISET BA cohort (the BA class of 2022) graduates transitioned into further education or into professional careers in the public sector, private industry, and research institutes. Our ISET bachelor program prepared them for either path as all graduates had to successfully pass our internship component and write independent research projects (BA Theses). The employers of several alumni have provided us with very positive feedback and eight students were nominated to the best BA thesis award and one student became the winner of the best gender thesis.

Curriculum

The ISET Master Program curriculum continues to expand through the adding and engaging new elective courses. We added multidisciplinary courses "Economic Psychology and Sociology, Political Philosophy and Contemporary Politics" and "Decision Making in Modern Western Pluralistic Societies" with the partnership the Public Administration program of TSU/Speyer. Which allows up to four ISET students to take the TSU/Shyer joint course.

Concentrations

In their second year at ISET, students had the opportunity to draw up an individual plan of elective courses based on their interests and career plans. As a result, they were enrolled in one of the concentrations offered in the academic program of 2021-22: Energy Economics, Inclusive Growth, Economic Theory, Macroeconomics Policy and Modern Data Analysis (MDA).

Master's Projects

The Master's Projects (MP) were supervised by local and visiting faculty. In the summer 2022, all the graduate students defended their master's projects successfully. Four students from the Class2022 cohort graduated with honor (one - Summa cum Laude and three - Magna cum Laude).

Summer Internships

Upon completion of the first year, all the graduate students do a summer internship to learn how to apply the theoretical knowledge gained at ISET into practice. ISET's friend and partner organizations create excellent conditions that are tailored specially for our students.

Exchange Programs

- The Master program hosted 7 international students from the University of Clermont Auvergne (UCA) within the general cooperation agreement between UCA and ISET/TSU to spend one full semester at ISET.
- ✓ In total ISET hosted 19 international students within the TSU Erasmus mobility program to spend a study semester at ISET.
- ✓ ISET/TSU and Freie Universität Berlin (FUB) School of Business & Economics started work on Double Degree Master Program "Economic Systems" in the spring 2022. According to the cooperation agreement which is still in discussion process the students' study for the first year at ISET-TSU and for the second year at FUB, it includes jointly supervised Master Thesis by one FUB and one ISET-TSU faculty member and conducted in Berlin.


